VACANCY CIRCULAR – AMENDED

Bhopal, Dated 4th March, 2017

Sub: Filling up the post of Managing Director (MD) in MP Power Transmission Company Ltd., Jabalpur.

Government of Madhya Pradesh has unbundled the Madhya Pradesh State Electricity Board (MPSEB) and separate companies (one Generation, one Transmission, Three Distribution and one Trading Companies) have been formed. These companies have been granted autonomy with effect from 1st June 2005. M.P. Power Transmission Company Ltd., Jabalpur is looking after the work of power transmission in the State.

2/ The present Managing Director of MP Power Transmission Co. Ltd. is completing his tenure in April, 2017. Therefore, Government of M.P. is seeking a suitable candidate to appoint as the Managing Director of MP Power Transmission Company Ltd. with headquarter at Jabalpur. The MD of the company in his capacity as CEO, will be responsible for overall management of the company with focus on improving performance of the company. The incumbent should have a proven track record and have the initiative, capacity and drive to lead organizational transformation. The responsibilities of the MD include development and implementation of the company's business plan, ensuring improvement in operational and financial performance and managing key stakeholders. The MD is likely to get a pay scale of Director / Executive Director (Rs.37400/- – Rs.67000/- with Grade Pay of Rs. 10000/-) of the Company (M.P. Power Transmission Co. Ltd.) with similar perquisites.

3/ The candidate's age should not be more than 60 years at the time of making application. The Managing Director shall be appointed for the duration not more than three years and shall be eligible for reappointment only for one more term as per provisions of Articles of Association of the company.

4/ **Eligibility Criteria :-** Officers fulfilling above criteria, with experience in Administrative / Technical / Finance or Management functions having worked as Chief Engineer or above in the respective cadre preferably in Power Sector Company.

5/ The candidates may submit their applications by post / email at the address given in paragraph 6 below in advance alongwith curriculum vitae and names of three referees. **Last date for receipt of applications is 25th March, 2017.** The following documents would also be required in respect of applicants :-

- (i) CR grading for past five years
- (ii) Vigilance status and details of major/minor punishment during last 5 years.
