PUBLIC NOTICE

Sub: Application for the post of Two Members, Madhya Pradesh Electricity Regulatory Commission (MPERC) – Inviting applications.

Madhya Pradesh Electricity Regulatory Commission (MPERC) has been constituted with a Chairperson and two Members. Government of Madhya Pradesh has constituted a Selection Committee under the provision of the Electricity Act, 2003 to fill up the post of Two Members of MPERC, which shall fall vacant with effect from 11.12.2017 and 2.1.2018, respectively. It has been decided to invite applications from the interested eligible person for selection on these posts.

2. In term of the provision under Section 84(1) of the Electricity Act, 2003, the Member of the MPERC shall be a person of ability, integrity and standing having adequate knowledge of, and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. In addition, the applicant should at least be a graduate and should have worked on a post with pay scale equal to or higher than that of Joint Secretary to Government of India / Chief Engineer (preferably holding a degree in Electrical or Mechanical Engineering).

3. An applicant who is in service must submit an undertaking from his employer that they would have no objection in relieving him in case he is offered appointment.

4. The applicant should not have any financial or other interest, which is likely to prejudice his functioning as a "Member of the Commission". A declaration in format given at Annexure-I should be furnished by the candidate alongwith his / her application.

5. In terms of the provision of Section 89 of Electricity Act, 2003, the Member shall hold office for a term of 5 years from the date he enters upon the office.

Provided that he shall not hold office as such after he has attained the age of 65 years.

6. The salary, allowances and other terms and conditions of service of the Member shall be such as prescribed by the State Government.

7. The last date of receipt of application is 25.11.2017. The envelope containing application may be subscribed as "Application for the post of Member MPERC".

8. The applicants are requested to mention the following in the resume:-

Name, age, date of birth, position now held, educational qualification, detail of posts previously held with experience in any of the field of Law, Economics, Commerce, Finance, Accountancy, Administration or Engineering.

The application should also contain the details of any office held, employment, consultancy works that he may have engaged in clearly indicating his role and contribution thereof in respect of following business namely:-

- i. Generation, transmission, distribution or supply of electricity.
- ii. Manufacture, sale or supply of any fuel for generation of electricity.
- iii. Manufacture, sale, lease, hire or hire or otherwise, supply of or dealing with machinery, plant, equipment, apparatus or fittings for generation, transmission, distribution or supply or use of electricity, and
- iv. Any entity providing professional service to any business referred above.
