Tenders, Purchase & registration of contractors ENCLOSURE TO COMMERCE & INDUSTRY DEPARTMENT MEMO NO. 5/7/78/B/XI 29-4-1978 AMENDMENTS IN THE STORE PURCHASE RULES SANCTIONED VIDE C&I DEPTT. MEMO NO./11208/3209/XI/A DATED 26-8-74

- 1. The first order of preference of the "preamble to rule" may be deleted & the remaining items may be renumbered accordingly.
- 2. Competent authority with director of industries in the preamble to rule may be substituted as under :-
 - "competent authority shall give preference to articles manufactured by the small scale industries of madhya pradesh registered as such for the concernd articles with the director of industries"
- 3. The parts 1, 2, & 3 may be substituted by the following: -
 - 1. The rules express a definite preference for articles which are produced by small scale industries of Madhya Pradesh.
 - 2. "The difference in the character of the preference, which may be given, should be carefully noted. In the case of first four categories mentioned in the preamble—the condition is that—the quality is sufficiently good for the purpose, and for the fifth category that the articles are of suitable type and requisite quality. The means that tshe articles coming under the first four categories should be accepted in that order unless it is considered that the quality is affinity not up to the standard required—even though articles manufactured else where and imported articles may be considered to be of better quality."
 - 3. "The other kind of preference referred to in the rules is the reservation for certain articles produced or manufactured by the small scale industries, to be purchased only though the M.P. LAGHU UDYOG NIGAM LIMITED."
 - 4. Para 9 may be substituted by "with reference to the principles of preference and reservation mentioned in the preamble, tendorers should be requested to furnish information in regard to the country of manufacture and/or origin of the material used in the manufacture of the articles"
 - 5. Rule 2 may be substituted by the following:
 - "Tenders shall be invited India and abroad also when considered desirable for the supply of all articles which are purchased under rules 1 to 5 unless the value of the order to be placed Is small of sufficient reason to be recorded exist which indicate that is not in the public interest to call for tenders. No tenders which fails to comply with conditions, as to delivery and payment prescribed in rule 1, shall be accepted, provided that subject to rule 14 where purchase of items reserved in annexure "B" for the registered small scale industries of Madhya Pradesh is to made, no tender shall be invited and the rates quoted by the M.P. Laghu Udyog Ltd. Shall be binding on the competent authority."

- 6. In rule, 7- "provided that...... shall not apply may be substituted by:-Provided that where purchases are made through the M.P.Laghu Udyog Ltd. The above restriction shall not apply.
- 7. Rule 14 and its notes may be substituted by the following: Rule 14, "Articles included in annexure "B" which is subject to revision from time to time produced or manufactured by small scale industries of Madhya Pradesh registered as such with director of Industries for concerned articles shall be purchased through the M.P. Laghu Udyog Ltd. Only at the rates fixed by them. No tenders for purchase of such articles shall be called by the competent authority separately.
- **NOTE: 1**. The Madhya Pradesh Laghu Udyog Nigam Ltd shall circulate lists of small Scale industries product industries intended to be marketed through the Nigam The heads of department and the industries organizations from time to time.
- **Note 2.** The M.P. Laghu Udyog Nigam shall float tenders, keeping in view the demands of various departments for term of standard specification only. However, in case any department requires an item of particular specification suiting to their requirements, the M.P. Laghu Udyog Nigam shall invite tenders accordingly.
- **Note 3.** The respective purchasing department shall nominate their representatives on the Laghu Udyog Nigam Marketing Committee for opening tenders and finalization of rates.
- Note 4. The rates decided the Marketing committee of Laghu Udyog Nigam shall be binding on the purchasing departments.

 In case the purchasing authority is not satisfied about the quality of item competence of manufacturer the matter shall be decided by a joint committee consisting of the purchasing office the director of industries and the Laghu Udyog Nigam.
- **Note 5.** The aforesaid Marketing Committee many enter into negotiations with the tenders if necessary.
- Note 6. The rates thus arrived at by the Marketing Committee of the Laghu Udyog Nigam shall be binding on the purchasing departments and all other departments requiring such items of the same specifications. No tenders shall be separately floated by the individual departments for the same items. in case of any dispute in regard to the rate with the purchasing department, the matter shall be referred to the Government (Commerce and Industry Department in Consultation with Finance Department) for decision.
- **Note 7**. While distributing the orders amongst the tendering units, the capacity, location and past performance of the unit along with the destination of the supplies shall be considered.

- **Note 8**. Normally the inspection of goods shall be made at the indenting stores. However, where necessary inspect on may be arranged at the manufacturing works.
- **Note 9.** In case of dispute between the manufacturing unit and the purchasing departments where supply have been inspected at works, the matter shall be referred to the Marketing Committee of Laghu Udyog Nigam for arbitration whose decision shall be final and binding on both the parties in all other cases the decision of the purchasing department shall be final and binding.
- **Note 10.** All payment shall be routed through the laghu Udyog Nigam . The departments should romit payment to laghu udog nigam within 21 days of the receipt of material . in case of delay the laghu udog nigam shall charge 1-1/2 % p.m. interest on payment due from the date of receipt of material.
- **Note 11.** The laghu udyog nigam shall release payment to the supplying small scale industriles within 10 days of the receipt of payment from the purchasing department.
- 9. paragraph 50 and 51 may be substituted by:
 50 . The intention of rule 14 is that item, reserved for purchese from
 the small scale industries shall be purchased from these industries
 only. Whenever such items are required to be purchased an ident
 should be placed with the laghu udyog nigam without inviting tenders
 and reasonable time should be given to them for making the supply
 only if the M.P laghu Udyog Nigam cortify their inability to make the
 purchase should be made from other sources in accordance with these
 rules.
 - The purchasing authority while sending the bills to treasury shall record a certification on it to the effect that provisions of rule 14 have been fully complied with ".
