Agenda item No. 2: ACTION TAKEN ON THE DECISIONS OF THE EXECUTIVE COMMITTEE IN ITS MEETING DATED 31st MARCH, 1990.

It was pointed out by the Secretary, Science & Technology that Dr. S. Khan has given representation about Incharge of Remote Sensing Applications Centre to all the members of the EC. The DG sensing the EC that the matter is being examined and will be informed to EC in due course.

Agenda item No. 3: RECOMMENDATION OF THE FIVE MEMBER COMMITTEE.

The staff structure proposed in the Five Member Committee for the Council's office, Remote Sensing Applications Centre, Central Laboratory Facility, Library-cum-Scientific Information Centre and Documentation Centre was discussed and approved.

With reference to the units funded by the Govt. of India, Raipur and at Jagadalpur, DG explained that the Govt. of India has fully funded two cells - one at Raipur primarily for the purpose of Entrepreneurship Development and the other at Jagadalpur for Tribal Development. DG's view was that these two units have made good Development. DG's view was that these two units have made good start by pursuing objectives laid by the Govt. of India. In case, Govt. of India does not support these Centres beyond the VIIth Plan period, Council would like to run them. He further pointed out that the approach paper of the Planning Commission to be considered at the next National Development Council meeting has suggested the setting up of District S&T Centres with the objective of promoting integrated local area planning in the S and T Chapter of the document. At a meeting held under the chairmanship of Additional Chief Secretary, Rural Development Department, Govt. of MP, it was felt that a few districts would be chosen in the State to begin with. In case the Council takes over the Centres they will then make Regional Centres for the purpose of overall development of their respective region.

After discussion it was decided that the Council of Science and Technology may evaluate these Centres and submit a report for consideration of EC, in case the Central Govt. support does not continue beyond the VIIth Plan.

The EC further decided that for the Scientific and Non-Scientific Staff who have come on deputation and completed the tenure as well as those who are working on deputation, may be considered for absorption, in case they have no objection.
