Notification

The 7th May, 1998

No. GSR 27/Const/Art./309/98.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules regulating the recruitment and conditions of service of persons appointed to the Haryana Ayurvedic Department Headquarter Ministerial (Group B) Service, namely:—

Part I-GENERAL

Short title and commencement:

- (I) These rules may be called the Haryana Ayurvedic Department Headquarter Ministerial (Group B) Service Rules, 1998.
 - (2) They shall come into force on the date of their publication in the official gazette.

Definitions:

- 2. In these rules, unless the context otherwise requires,-
 - (a) "Commission" means the Haryana Public, Service Commission;
- (b) "Director" means the Director of Ayurveda, Haryana;
- (c) "Government" means the Haryana Government in the Administrative Department;
- (d) "institution" means -
 - (i) any institution established by law in force in the State of Haryana ; or
 - (ii) any other institution recognised by the Government for the purpose of these rules;
- (e) "recognised university" means,-
 - (i) any university incorporated by law in India; or
 - (ii) in case of degree, diploma or certificate obtained as a result of an examination held before the 15th August, 1947 the Punjab, Sind or Dacca University; or
 - (iii) any other university which is declared by the Government to be recognised university for the purpose of these rules;
- (f) "Servico" means Haryana Ayurvedic Department Headquarter Ministerial (Group B) Servico.

Part II-RECRUITMENT TO SERVICE

Number and character of posts:

3. The Service shall comprise the posts shown in Appendix A to these rules :

Provided that nothing in these rules shall affect the inherent right of the Government to make addition to, or reductions in, the number of such posts or to create new posts with different designations and scales of pay, either permanently or temporarily.

Nationality, domicile and character of candidates appointed to Service

- 4. (I) No person shall be appointed to any postinable Service, unless he is,--
- (a) a citizen of India ; or
- (b) a subject of Nepal ; or
- (c) a subject of Blattan ; or
- (d) a Titeran refugee who came over to India before the Ist January, 1962, with the intention of permanently settling in India; or
- (e) a person of Indian origin who hab migrared from Pakisian, Burma, Sri Lanka, or any of the Bast African Countries of Konya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zumbin, Mahawi, Zaire and Ethiopia, with the intention of permajoutly selding in India;

Provided that a person belonging to any of the categories (b), (c), (d) or (s) shall be a person in whose favour a certificate of eligibility has been issued by the Government.

- (2) A porson in whose case certificate of eligibility is necessary may be relimited to an examination or interview conducted by the Commission, but the offer of appointment may be given only after the accessary eligibility certificate has been issued to from by the Covernment.
- (3) No person shall be appointed to any post in the Service by direct recruitment, unless he produces a certificate of character from the Principal Academic Officer of the University, College, School or Institution last attended, if any, and similar certificate from two other responsible persons, not being his relatives who are well acquainted with this this private life and are unconnected with his University, College, School or Institution.

. Appointing Authority :

5. Appointment to the posts in the Service shall be made by the Government.

Qualifications !

Disqualitication :

- 7. No person,-
- (a) who has entered into or corrected a marriage with a person having a spouse living; or
- (b) who having a spouse tiving, has extered into or contracted a marriage with any

Shall be eligible for appointment to any post in the Service :

Provided that the Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person, and the other party to the marriage and there are other grounds for to doing, exempt any person from the operation of this rule.

Method of recruitment

- 8. (4) Recruitment to the Service shall be made ,-
- (a) in the case of Establishment Officer-
 - (i) by promotion from amongst the Superintendent; or
 - (ii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;
- (b) in the case of Superintendents-
 - (i) by promotion from amongst Deputy Superintendents or Personal Assistant;
 - (ii) by transfer or deputation of an officer/official already in the service of any State Government or Government of India;
- (3) All Promotions unless otherwise provided, shall be made on seniority-cum-merit basis and seniority alone shall not confer any right to such promotion.

(1) Persons appointed to any post in the Service shall remain on probation, for a period of one years:

Provided that-

- (a) any period, after such appointment, spent on deputation on a corresponding or a higher post shall count towards the period of probation;
- (b) any period of work in equivalent or higher rank, prior to appointment to any post int he Service, may, in the case of an appointment by transfer, at the discre-tion of the appointing authority, he allowed to exented sowards the period of probation fixed under this rule; and
- (c) any period of officiating appointment shall be reckoned as period spont on probation, but no person who has so officiated shall, on the completion of the prescribed period of probation, be entitled to be confirmed, unless he is appointed against a permanent vacancy.

- (2) If, is the opinion of the appointing authority, the work or conduct of a person during the period of probation is not satisfactory, it may,—
 - (i) revert him to his former post ; or
 - (ii) deal with him in such other manner as the terms and conditions of the previous appointment permit.
- (3) On the completion of the period of probation of a person, the appointing authority may ;—
 - (a) if his work or conduct has, in its epinion, been satisfactory,---
 - ... (i) confirm such person from the date of his appointment, if appointed against a permanent vacancy; or
 - (ii) confirm such person from the date from which a permanent vacancy occur, if appointed against a temporary vacancy; or
 - (iii) declare that he has completed his probation satisfactorily, if there is no permanent vacancy; or
 - (b) If his work or conduct has, in its opinion, been not satisfactoriy,-
 - revert him to his former post or deal with him in such other manner as the terms and conditions of his previous appointment permit;
 - (ii) extend his period of probation and thereafter pass such order, as it could have passed on the expiry of the first period of probation;

Provided that the total period of probation, including extension, if any, shall not exceed three years.

Seniority:

10. Seniority, tweer se of the members of the Service shall be determined by the length of continuous. Service on any post in the Service:

Provided that where there are different cadres in the Service, the seniority shall be determined separately for each cadre:

Provided further that in the case of two members appointed on the same date, their seniority shall be determined as follows:—

- (a) a member appointed by promotion shall be senior to a member appointed by transfer;
- (b) in the case of a member appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in the appointments from which they were promoted or transferred; and
- (c) in the case of members appointed by transfer from different cadre, their seniority shall be determined according to pay, preference being given to a member, who was drawing a higher out of pay in his provides anneau mont; and

if the rates of pay draws are also the same. then by the length of their Service in the appointment and if the length of such service is also the same, the old member shall be service to the younger member.

Liability to serve.

- (1) A member of the Service shull be liable to serve at any place whether within
 or ourside the State of Haryana, on being ordered so to do by the appointing authority.
 - (2) A member of the Service may also be deputed to serve under ,-
 - (i) a company, an association or a body of individuals whether incorporated or not, which is wholly or substantially owned or controlled by the Government, a sumicipal Committee or a local authority or university within the State of Haryana;
 - (ii) the Central Government or a company, as association or a body of individuals, whether incorporated or not, which is wholly or substantially owned or controlled by the Central Government; or
 - (iii) any other State Government, an international organisation, an autonomous body not controlled by the Government or a private body :

Provides that no member of the Service shall be deputed to the Central or any other State Government or any organization or hody referred to in clauses (ii) or (iii) except with his consent.

Pay, leave, pension and other matters

12. In respect of pay, leave, pension and all other matters, not expressly provided for in these rules, the members of the Service shall be governed by such rules and regulations as may have been, or may placedier by, adopted or made by the competent amberity under the Constitution of India or under any law for the time being in force by the State Legislature.

Discipline, penalties and appeals.

13. (1) In matters relating to discipline, penalties and appeals, members of the Service shall be governed by the Haryana Civil Service (Punishment and Appeal) Rules, 1987, as amended from time to time:

Provided that nature of penalties which may be imposed, the authority empowerof to impose such penalties and appellate authority shall subject to the provisions of any law or rules made under article 309 of the Constitution of India, be such as are specified in Appendix C to these rules.

(2) The authority competent to pass an order under clause (c) or clause (d) sub-rule (1) of rule 9 of the Haryana Civil Services (Punishment and Appeal) Rule, 1987, and appellate authority shall be as specified in Appendix D to these rules.

Vaccination.

14 Every member of the Service shall get himself viscinated or re-vaccinated as and and when the Government so directs by special or general order.

Outh of allegiance.

15. Every member of the Service, unless he last already done so, shall be required to take the coth of allegiance to India and to the Constitution of India as by law established.

Power of relaxation.

16. Where the Government is of the opinion that it is necessary or expedient so to do it may, by order, for reasons to be retorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

Special provision

17. Notwithstanding anything contained in these rules ,the appointing authority may impose special terms and conditions in the order of appointment if it is deemed expedient to do so.

Reservation.

18. Nothing contained in these rules shall affect reservations and other concessions required to be provided for Scheduled Castes, Backward Classes, Ex-servicemen, Physically handicapped persons or any other class or category of persons in accordance with the order issued by the State Government in this regard from time to time:

Provided that the total percentage of reservation so made shall not exceed fifty percent, at any time.

Repeal and savings.

19. The Punjab Ayurvedic Department (Class-III) Ministerial Service Rules, 1963, in their application to the State of Hatyana are $_i$ hereby repealed :

Provided that any order made or action taken under the rules so repealed shall be deemed to have been made or taken under the corresponding provisions of these rules.
